The City of Norwood Payneham & St Peters recognises the importance of providing high quality community facilities to enhance Community Well-being.

In 2016, the Council undertook a review of the Norwood and Payneham Memorial Swimming Centres to ensure that these valued assets continue to remain relevant to the needs and expectations of our community.

The Council resolved that the Long Term Strategy for the Council's Swimming Centres will continue to be based on a two (2) Centre, outdoor pool model. Both the Payneham Memorial Swimming Centre and the Norwood Swimming Centre will be redeveloped to ensure that they will continue to provide adequate facilities for the community over the next 20 years.

In developing design option(s) for the redevelopment of the Swimming Centres, the Council has undertaken an extensive review of the Centres operations, the condition of the existing pool infrastructure, the market in which the Centres operate and competitive challenges.

The Council engaged feedback from the community through various methods, including patron surveys, facilitated Focus Group and information sessions, to inform the development of the preferred options.

The preferred design option for the Payneham Memorial Swimming Centre is detailed over the page.



Payneham Memorial Swimming Centre - Preferred Design Option

Preferred Design Option

The preferred design option for the Payneham Memorial Swimming Centre targets an identified gap in the recreational market within Adelaide's eastern region, specifically addressing the needs of teenagers.

This redevelopment option will provide a wide range of amenity and facility improvements including:

- Refurbishment of the existing 50 metre outdoor swimming pool to meet the needs of lap swimming, squads, school carnivals and general recreational swimming and fitness for all abilities, including:
 - installation of a ramp at the shallow end to allow disabled access;
 - replacement of scum gutters with wet deck entry;
 - installation of new filtration system and refurbishment of the plant room; and
 - retiling of the pool.
- Replacement of the existing learner's pool with a larger pool, which will include a ramp to enable disabled access.
- Introduce shallow water spaces with play equipment aimed at babies and toddlers by replacing the toddler's pool with an interactive splash pad.
- Development of a water play park with waterslides and interactive water elements to address the identified gap in the market and to enhance the Payneham Memorial Swimming Centre as a recreational destination for all ages.
- An inflatable obstacle course to complement the water play park.
- Installation of additional shade and the upgrade of building amenities, barbeque and picnic facilities.
