#### 4.2 EASTERN REGION ALLIANCE (ERA) WATER – APPOINTMENT OF INDEPENDENT CHAIRPERSON

### PURPOSE OF REPORT

The purpose of this report is to seek the Council's endorsement to re-appoint Mr Geoff Tate as the Independent Chairperson of the Board of ERA Water (the Board).

### BACKGROUND

As Elected Members are aware, ERA Water is a Regional Subsidiary, which has been established under Section 43 of the *Local Government Act 1999*. The Constituent Councils (ie the owners of ERA Water) are the Cities of Burnside, Norwood Payneham & St Peters and Town of Walkerville.

At its meeting held on 21 July 2021, the Council considered a report regarding the appointment of the Independent Chairperson, for a two (2) year term and resolved the following:

That the Council endorses the appointment of Mr Jeff Tate as the Independent Chairperson of ERA Water for a two (2) year period, commencing from the date of the last decision made in this respect by the Constituent Councils.

Mr Tate's term as Independent Chairperson is due to conclude on 23 July 2023.

Pursuant to Clause 3.4.3 of the ERA Water Charter, the Chief Executive Officers of the three (3) Constituent Councils, are required to provide a recommendation to the Constituent Councils regarding the appointment of the Independent Chairperson, including the fee to be paid and other terms and conditions to attach to the appointment.

Prior to determining whether to undertake a process to recruit a new Independent Chairperson, Mr Tate was asked whether he was interested in continuing as the Chairperson for a further term of two (2) years.

Mr Tate has advised of his willingness to be re-appointed for a further two (2) year term.

On this basis, at its meeting held on 18 May 2023, the Board resolved that:

- 1. The Board notes that the Chair's term ends in July 2023, and requests that the Constituent Council CEOs initiate the process of appointing the Chairperson.
- 2. The Board recommends to the Constituent Council CEOs that the current Chair be reappointed.

At its meeting held on 13 June 2023, the City of Burnside endorsed the Board of ERA Water's recommendation to re-appoint Mr Tate to the position of Chairperson for a further two (2) year term.

At its meeting held on 26 June 2023, the Town of Walkerville endorsed the Board of ERA Water's recommendation to re-appoint Mr Tate to the position of Chairperson for a further two (2) year term.

### FINANCIAL AND BUDGET IMPLICATIONS

The sitting fee for the Independent Chairperson is paid by ERA Water.

The existing sitting fee is \$12,252. However, in recognition that the sitting fee has not been reviewed or increased since July 2021, the Chief Executive Officers have recommended that the sitting fee be increased to \$13,000.

At its meeting held on 13 June 2023, the City of Burnside endorsed the recommendation to increase the sitting fee to \$13,000 per year.

The Town of Walkerville, at its meeting held on 26 June 2023, also endorsed the recommendation to increase the sitting fee to \$13,000 per year.

#### **RISK MANAGEMENT**

Pursuant to ERA Water Charter, the Constituent Councils must appoint an Independent Chairperson to the ERA Water Board. As such, the re-appointment of Mr Tate would satisfy the requirement of Clause 3.4 of the Charter.

#### DISCUSSION

The current Board of ERA Water comprises four (4) Members including the Independent Chairperson.

Cr Grant Piggott is this Council's appointee to the Board.

ERA Water is a significant undertaking by the Constituent Councils and as such, it requires an Independent Chairperson who understands the water industry and can 'steer' the Authority to meet the objectives of the Project.

The Chief Executive Officers of the Constituent Councils are of the view that Mr Tate is a committed and dedicated Chairperson. He understands the water industry, the details of the ERA Water Project and its challenges and has worked diligently and assiduously since his appointment, often going 'above and beyond' the duties of an Independent Chairperson.

As such, Mr Tate's re-appointment for an additional term of two (2) years is considered appropriate and in the best interests of ensuring the success of ERA Water. In short, ERA Water requires stability at the Board level and Mr Tate's re-appointment will provide confidence to the Constituent Councils.

# OPTIONS

Essentially, the Council has two (2) options in respect to this matter. The Council can either reappoint Mr Tate as the Independent Chairperson for an additional two (2) year term or it can resolve to undertake a recruitment process to select and appoint a new Independent Chairperson.

For the reasons contained in this report, it is recommended that Mr Tate be re-appointed for an additional two (2) year term.
