## PURPOSE OF REPORT

# DISCUSSION

The Australia Day Awards are presented annually to local citizens who are considered to have made outstanding contributions to the community.

A list of all Local Australia Day Award winners since 1999 has been prepared for the Council's information and a copy of this document is contained within **Attachment A**.

The Council has received two (2) nominations for the 2024 Citizen of the Year Award:

- Mr Ravi Hammond (Attachment B); and
- Ms Jane Durbridge (Attachment C).

The Council has received two (2) nominations for the 2024 Young Citizen of the Year Award:

- Mr Ethan Jiunn-Yow Chen (Attachment D); and
- Ms Abbey Wilkinson (Attachment E).

The Council has received two (2) nominations for the 2024 Community Event of the Year:

- One Planet Market (Attachment F); and
- Kaurna Cultural Ceremony (Attachment G).

The Council did not receive any nominations for the Award for Active Citizenship.

The number of nominations which have been received for the 2024 Awards is higher than in previous years. Additional marketing and word-of-mouth promotion throughout the community may have contributed to the number of nominations received.

# Award Criteria

The selection criteria for the *Citizen* and *Young Citizen of the Year* when considering an application is as follows:

- to be eligible, the person must be an Australian citizen;
- to be eligible, the person must be an Australian citizen under 30 years of age on January 26, 2022;
- the significance of the contribution to the community;
- an inspirational role model for the Australian community; and
- the scope of impact the individual's contribution has on the local government area.

Other factors to be considered include:

- personal, academic and professional achievements;
- demonstrated leadership, innovation and creativity;
- degree of difficulty and sacrifices made; and
- nature and length of activity or service.

The criteria when considering an application for *Community Event of the Year* is set out below:

- Who was the event for, what was its objective and did the event achieve these objectives?
- How many people attended or benefited from the community event?
- What impact did it have on the group/audience for whom it was held?
- Did the event have any other positive impacts for the community that it did not necessarily aim to achieve?
- Did the event receive any positive commendations from members of the community?
- Was there an environmental advantage?
- How was the event funded? Was it a not-for-profit event or was it planned to have a financial advantage?
- Did the organiser or organising body, work alone or as a team?
- Did the event involve broad community participation? And
- To be eligible, the person or group must be Australian Citizens.

There is however, no requirement or obligation on the Council to confer an Award if nominations are not worthy of an Award.

### OPTIONS

### Option One

The Council can confer the Award to the nominee, who the Council determines as meeting the criteria as set out by the Australia Day Council of South Australia.

### Option Two

The Council can determine not to confer Awards as part of the 2024 Australia Day celebrations.

### CONCLUSION

It is important to note that the Council does not have to confer Awards if the Council is not convinced that the nominations meet the criteria.

The Council's Australia Day celebrations will still feature a Citizenship Ceremony and therefore the event can proceed as planned, albeit without the Awards component.

### COMMENTS

# Reason for nomination - How has the person/organisation contributed to the community?

Ravi's dedication to nurturing the next generation of tech talent goes beyond mere participation; he has actively enhanced the fabric of community life and epitomised the spirit of active citizenship. Ravi's journey is marked by impressive milestones, such as securing third place globally in the NASA Space Robotics Challenge and interning at several top tech companies such as Google and Microsoft. However, his most significant contribution stems from his relentless dedication to empowering computer science students across Australia, particularly in Adelaide. Since 2019, Ravi has been touching the lives of hundreds of students annually, demystifying the world of tech and opening doors that many found impassable.

In 2020, Ravi founded "Ravi's Study Program" (RSP), a beacon of hope and practical support for aspiring tech professionals. This entirely free, annual bootcamp is ingeniously designed to train programming students to excel in coding interviews, a critical hurdle when seeking roles in prestigious tech companies. Ravi's approach doesn't just involve guidance regarding technical skills; it's about building confidence, community, and opportunities for real-world success.

### How has the nominee demonstrated active citizenship and enhancement of community life?

The impact of RSP is quantifiable: in just three years, it has graduated 131 students, leading to over 200 job offers from industry giants like Google, Amazon, Jane Street, Palantir, Atlassian, and more. Remarkably, 75 of these were positions within big-tech, an achievement that underscores the program's efficacy and Ravi's commitment.

While Ravi's initiative has garnered immense gratitude from his students, it's his altruistic approach that deserves acclaim. He has not sought profit or fame; instead, he invested his time, skills, and personal funds to uplift others. His work is a labour of love, an act of genuine community service that has yet to receive the broader recognition it truly deserves. This is demonstrated through the countless hours he pours into students at an individual level. He builds long-term relationships with his students and supports them in their forward endeavours in any way he can. I can certainly attest to this, being someone who's benefited from the millions of written and spoken words of advice he's handed to me over the past four years.

Through this program, he has built a community of students who have blossomed from Ravi's guidance, and are now volunteering in masses to support the program and other like-minded students in general, giving back to students in the years below them. This attitude stemmed from Ravi's altruism. Ravi is widely considered the most influential person in the University of Adelaide in particular.

### How has the nominee's contribution been recognised elsewhere?

Recently, Ravi has founded RSP as a not-for-profit charity. He's aiming to take the program to the national level, since it's a program that is already being recognised by top universities across Australia because of the success it has brought Adelaide university students. Because of Ravi, the University of Adelaide in particular has propelled from being a relatively unknown name in Australia's big tech company offices to now being tied with University of New South Wales for the most multinational interns produced from a university, a feat that would have been virtually impossible without his dedicated involvement.

It's not just Australia that's had the privilege of accessing this program, but his altruism has been noticed sporadically across the globe from students in England, America, Pakistan, India, and more.

**Reason for nomination - How has the person/organisation contributed to the community?** Abbey is an inspiring community leader, demonstrating remarkable mentorship abilities and a commendable capacity for driving positive change whenever she recognises its necessity.

Each year, 12 young people, from ages 14-18 are selected to be members of the South Australian Youth Forum (SAYF). After the program, Forum members are invited to continue with the next year's members as mentors and become part of the Executive Team. This is an opportunity for young people to have a chance to be leaders in their community and enhance their skills through mentoring the new members.

Abbey was selected to be a South Australian Youth Forum member in 2022 and progressed to become an Executive member and mentor for the Forum in 2023.

The Annual Report is the main goal of the Forum and includes meeting discussions, models of engagement and data collection from surveys. Additionally, each Forum member has an opportunity to write on an issue that they are passionate about / have personal experience with. The members are cited for their work and together, as a Forum, we decide upon recommendations for each issue.

At the end of the year, the Forum members meet with Ministers, Politicians, Community Leaders, Local Government and Businesses to present the findings from the report and to educate the decision-makers on their role to enact certain changes.

In 2022, Abbey contributed her passion, commitment and dedication to youth empowerment to help present the SA Youth Forum Annual Report to:

- Ministers for Human Services, Women, Child Protection, Domestic Violence Prevention, Business and Commerce, Transport and Arts, Education
- Shadow Minister for Youth and Communities
- 15 State Members of Parliament
- 6 Federal Members of Parliament
- 17 Local Councils
- 5 Academics from Universities across Australia
- Local Government Association of Youth Development
- Southern Youth Development Network
- Commissioner for Young People and Children
- Youth Affairs Council of South Australia
- Green Adelaide

Abbey has helped lead the Forum in 2023 and, as such, has become a co-author for the 2023 SA Youth Forum Annual Report. The Forum is excited to meet with the Minister for Human Services, Minister for Education and Shadow Minister for Youth in December 2023.

In addition to Abbey's work with the Forum, she was also elected as a year 12 Prefect by her peers and has contributed countless hours and service to making her school community increasingly healthier for the wellbeing of her fellow students.

How has the nominee demonstrated active citizenship and enhancement of community life? By becoming an Executive member in 2023, Abbey has demonstrated active citizenship through mentoring the new young people selected for the Forum's program. This has been through:

- Organising regular mentoring meetings with Forum members to help them prepare for the monthly SA Youth Forum meetings.
- Providing regular check-ins with Forum members about how they are managing school and other commitments.
- Sharing appropriate opportunities available for the Forum members to become involved with.

In addition to Abbey's mentorship, she also established the Gender Inequality sub-committee of the Forum which conducted a research project into young peoples' experiences with gender inequality at school. The group recognised tangible recommendations for the findings from the project. The Forum was invited to meet in the Town Hall in May 2023, where they officially published the data from this research project.

Abbey has actively collaborated with SA Power Networks as a youth representative, offering valuable insights into their Regulatory Reset 2025–2030 Plan. Additionally, she has contributed to the development of the Department of Human Services' new Youth Action Plan and played a pivotal role in the Uniting Communities #UnlockingLoneliness campaign. In these endeavours, Abbey effectively represented the voices of young people, providing insightful evaluations to enhance the impact and effectiveness of these initiatives.

In Abbey's term on the SAYF, she has worked closely with the Department of Human Services (DHS) on their new coercive control campaign, The See the Signs Campaign. Abbey worked on both stage 1 in 2022 and stage 2 in 2023 of this campaign. She provided excellent feedback to the Department about improving the campaign to ensure more relatable impacts on the lives of young people who see it.

Lately, Abbey was a selected SAYF Executive member to work in partnership with the Department of Human Services to commence a research project on coercive control and young people. Despite this being a challenging research project, Abbey showed diligence and leadership in how she worked with the SAYF team and the young people involved, as well as responsibly liaising with DHS. This project is significant in gaining an understanding of young peoples' awareness of coercive control and shaping the direction of the See the Signs Campaign stage 3.

In the last few months, the SAYF has commenced a partnership with Flinders University to collect worldfirst data on how loneliness affects young people. This is a super exciting opportunity and Abbey has volunteered many hours to be part of co-designing the process of academic research collection. Abbey and the Forum are excited to continue this project into 2024 after recently receiving a grant to explore this topic further.

Overall, Abbey embodies kindness, determination, respect, and passion as a dedicated citizen and community leader. Despite being only 18, she remains unwavering in her commitment to amplifying the voices of young people, actively working towards ensuring their perspectives are heard and valued in decision-making arenas.

Abbey has been acknowledged by receiving a Premier's Recognition for Outstanding Service to the Community and a Volunteering SA Award for being a Community Changemaker.

# Reason for nomination - How has the person/organisation contributed to the community?

How has the event contributed to the community?

The Kaurna Cultural Ceremony was organised by the Kensington Residents Association on 9 July 2023 and held in Borthwick Park, which is nestled in the suburb of Kensington along Second Creek. The event attracted over 100 residents from across the district. The purpose of the event was to engage Kaurna leaders to collaborate with the community, in order to honour deep time culture, language, wisdom and knowledge of the country where we live.

Borthwick Park is located on an ancient place known as Karra Yerta (river red gums along the creek). Kaurna People lived around the creek, gathering for ceremony and cultural activities for many thousands of years. Historic sources describe the original landscape of the eastern plains as: "...a magnificent gum forest with an undergrowth of Kangaroo Grass so high that people travelling between Adelaide and Kensington lost their way."

The first Anglican Bishop of the Province of South Australia; Augustus Short, recorded that he had seen as many as 300 Aboriginal people assembled "in the heart of Kensington" for a ceremonial gathering at the bend of Second Creek, which is now part of Borthwick Park.

The event guided by Kaurna leaders, included ceremony, singing, dancing, storytelling, and cultural education around bush foods, native animals and medicinal plants. The importance of belonging and feeling deeply connected to the places we live is important for all of us. Experiencing Kaurna culture enriched the attendee's sense of connection to place, and built civic pride, trust and connection to each other which strengthened wellbeing and sense of belonging.

#### How has the nominee demonstrated active citizenship and enhancement of community life? How has the nominee demonstrated active citizenship and enhancement of community life?

Local residents, especially young people and families, expressed interest in understanding and honouring the local Kaurna culture and stories. The Kaurna Cultural Ceremony helped deepen respect for each other and reinforce the importance of being part of a compassionate community in an ancient place. It encouraged people to take greater responsibility in caring for the environment and make choices in their own lives that contribute to replenishing the earth's fragile resources in small ways. This event will catalyse future cultural activity and learning and demonstrate how local communities can lead and benefit from genuine, heartfelt reconciliation. The Borthwick Park biodiversity project will continue to play a critical role in regularly bringing volunteers of all ages and the broader community together to progress future cultural and environmental activity. It is difficult to predict the unique and ongoing value of developing a genuine and trusted relationship between the Kaurna and local communities, but it is anticipated that this event will catalyse future cultural activity and learning and demonstrate how local communities can lead and benefit from genuine, heartfelt reconciliation. The Borthwick Park Biodiversity Project will continue to play a critical role in regularly bringing volunteers of all ages and the broader community together to progress future cultural and environmental activity. It is anticipated that information shared with the local community by Kaurna Leaders about plants, animals and cultural activity linked to Second Creek will be included in permanent signage in Borthwick Park for future visitors to experience. The project will reinforce and amplify the unique biodiverse park environment as a place of outdoor learning for the local kindergarten and schools.

The event may also inspire other neighbouring communities to undertake similar projects which will further enrich the capability and resilience of the greater Adelaide area as we endure and adapt to the impacts of climate change and other environmental challenges, guided by ancient wisdom.
