PURPOSE OF REPORT

The purpose of this report is to present the nominations which have been received for the 2025 Australia Day Awards for the Council's consideration.

BACKGROUND

Every year the Council, in association with the *Australia Day Council of South Australia*, invites nominations from the community for the Citizen of the Year, the Young Citizen and the Community Event of the Year Awards, as well as an Award for Active Citizenship, where the person or group are not required to be Australian Citizens.

Promotion of the Awards has been undertaken via the Council's website, social media platforms and through promotional materials located at Council facilities (ie the Norwood Town Hall and Libraries) and by the Australia Day Council of South Australia.

The Council has received four (4) nominations for the *2025 Australia Day Awards*.

DISCUSSION

The Australia Day Awards are presented annually to local citizens who are considered to have made outstanding contributions to the South Australian community.

A list of all local Australia Day Award winners since 1999 has been prepared for the Council's information and a copy of this document is contained within **Attachment A**.

The Council has received one (1) nomination for the *2025 Young Citizen of the Year Award*:

- Mr Ethan Jiunn-Yow Chen (**Attachment B**)

The Council has received one (1) nomination for the *2025 Active Citizenship*:

- Mr Thomas Marlin (**Attachment C**)

The Council has received two (2) nomination for the *2024 Community Event of the Year*:

- Cheeky Grin Coffee Longest Table (**Attachment D**); and
- Donne Divine - In cammino con Dante (**Attachment E**)

The Council did not receive any nominations for the Award for Citizen of the Year.

There is no requirement or obligation on the Council to confer an Award if nominations are not worthy of an Award, however the selection criteria differs for each category.

Award Criteria

The selection criteria for the *Citizen* and *Young Citizen of the Year* when considering an application is as follows:

- to be eligible, the person must be an Australian citizen;
- to be eligible, the person must be an Australian citizen under 30 years of age on January 26, 2023;
- the significance of the contribution to the community;
- an inspirational role model for the Australian community; and
- the scope of impact the individual's contribution has on the local government area.

Other factors to be considered include:

- personal, academic and professional achievements;
- demonstrated leadership, innovation and creativity;
- degree of difficulty and sacrifices made; and
- nature and length of activity or service.

The criteria when considering an application for *Community Event of the Year* is set out below:

- Who was the event for, what was its objective and did the event achieve these objectives?
- How many people attended or benefited from the community event?
- What impact did it have on the group/audience for whom it was held?
- Did the event have any other positive impacts for the community that it did not necessarily aim to achieve?
- Did the event receive any positive commendations from members of the community?
- Was there an environmental advantage?
- How was the event funded? Was it a not-for-profit event or was it planned to have a financial advantage?
- Did the organiser or organising body, work alone or as a team?
- Did the event involve broad community participation? And
- To be eligible, the person or group must be Australian Citizens.

The selection criteria for *Award for Active Citizenship* is set out below:

- The person or group has demonstrated leadership in and for the community;
- The person or groups involvement in the community; and
- The scope of impact the person or groups work has on the community.

Please note: The person or group need not be Australian Citizens.

OPTIONS

Option One

The Council can confer the Award to the nominee, who the Council determines as meeting the criteria as set out by the Australia Day Council of South Australia.

Option Two

The Council can determine not to confer Awards as part of the 2024 Australia Day celebrations.

CONCLUSION

It is important to note that the Council does not have to confer Awards if the Council is not convinced that the nominations meet the criteria.

The Council's Australia Day celebrations will still feature a Citizenship Ceremony and therefore the event can proceed as planned, albeit without the Awards component.

COMMENTS

To assist the Council, a model recommendation for Recommendation 2 is set out below.

RECOMMENDATION 1

That pursuant to Section 90(2) and (3) of the *Local Government Act 1999* the Council orders that the public, with the exception of the Council staff present, be excluded from the meeting on the basis that the Council will receive, discuss and consider:

(o) information relating to a proposed award recipient before the presentation of the award;

and the Council is satisfied that, the principle that the meeting should be conducted in a place open to the public, has been outweighed by the need to keep the receipt/discussion/consideration of the information confidential.

RECOMMENDATION 2

1. That be selected as the successful candidate to receive the 2025 Active Citizen of the Year Award.
2. That be selected as the successful candidate to receive the 2025 Young Citizen of the Year Award.
3. That be selected as the successful candidate to receive the 2025 Community Event of the Year Award.
4. That the successful Award recipient and their family and friends be invited to accept the Australia Day Award at the Council's Australia Day Event to be held on 26 January 2025.

Or

That the Council determines not to grant an award under any or one of the categories as part of the 2025 Australia Day Celebrations.

That Donne Divine - In cammino con Dante, be selected as the successful candidate to receive the 2025 Community Event of the Year Award.

Seconded by Cr Clutterham and lost.

Cr Piggott moved:

Subject to it meeting the criteria as set out by the Australia Day Council of South Australia, that a second 2025 Community Event of the Year Award be awarded to Cheeky Grin Coffee Longest Table.

The motion lapsed for want of a seconder

Cr Robinson moved:

That Cheeky Grin Coffee Longest Table be selected as the successful candidate to receive the 2025 Community Event of the Year Award.

Seconded by Cr Duke and carried.

Reason for nomination - How has the person/organisation contributed to the community?

Ethan has made a significant impact on the community by bridging the gap between disadvantaged children and the benefits of sports.

Founded by Ethan, his initiative has raised over \$10,000 and reached 700 families, delivering sports programs to children who otherwise wouldn't have the opportunity.

Through sports, Courtside Champs not only promotes physical activity but also fosters a sense of community, teamwork, and resilience in the young participants.

Their efforts have extended beyond just local outreach, as all proceeds and donations go back towards equipment and scholarships to these families, providing them with much-needed relief and support.

This initiative has not only transformed lives locally but has also shown a commitment to global humanitarian efforts, making a lasting difference on multiple fronts.

How has the nominee demonstrated active citizenship and enhancement of community life?

Ethan revolutionised service learning in his community by stepping up to various ambassador roles in his community.

He represents the UN Youth SA organisation as a student ambassador, Green Adelaide as the Youth Coastal Ambassador. Garnering over 20 "student-coaches" he pulled players from the South Australia state team to coach in his NGO, he has invested in youth development by creating opportunities for young athletes to give back to their communities.

Through his initiative, Courtside Champs, Ethan has fostered a culture of mentorship and skill development, ensuring that disadvantaged and underrepresented children have access to quality sports coaching and positive role models.

His innovative approach has not only elevated the level of service learning in his community but has also empowered young leaders to take an active role in shaping the future, making a lasting impact on both the players and the broader community.

How has the nominee's contribution been recognised elsewhere?

Nominated for the South Australian Volunteer Award:

This award acknowledges the Ethan's dedication to volunteerism and their impactful service in the community.

UN Youth Global Citizenship Award: Recognizes his efforts in promoting global awareness and social responsibility among young people.

Reason for nomination - How has the person/organisation contributed to the community?

Thomas is a world class cellist and musician who could be playing in major cities like London or Sydney.

Because it was his own route (and passport to London via Singapore) post covid, he's committed himself to building the musical landscape in Adelaide through the grassroots of our music community.

He's a very busy private teacher who has contributed many pupils to the musical ecosystem, through Adelaide Youth Orchestras and Open Music Academy; he has significantly contributed to the success of St Peter's College Strings in ABODA Festival.

Thomas is a member of Adelaide Baroque- their success is building up more performance and listening opportunities for historically informed practice in SA- and a member of Tarawatta Trio, which as a member of Chamber Music Adelaide, is currently celebrating the legacy of Miriam Hyde.

Thomas is an active member of the freelance community in SA and in addition, he has formed the top quality Alma Moodie String Quartet with major professional players in Sydney, raising awareness of another historical female figure in Australian musical history.

How has the nominee demonstrated active citizenship and enhancement of community life?

He works so hard to deliver the best service to young cellists, to bring music to a new vanguard of young players, and to use classical music to provide for his family.

We are in Australia's UNESCO city of Music, and Thomas demonstrates total dedication to the principals of UNESCO cities of music re spreading awareness of and access to more live music opportunities in the community.

He was the cello tutor for the important Adelaide Baroque Academy and participates in Cello Weekends and concerts at Elder Conservatorium. He contributes his high level, ASO-available cello skills to thrive in an area that sadly has traditionally offered very low quality freelance scene, and in addition to that he has nurtured a loving family life for three children with no salary.

He is a hugely active sports fan for local teams in SA. In UNESCO City of Music's decade 2025, it would send a strong, positive message to publicly highlight the activities of a deserving, freelance musician.

How has the nominee's contribution been recognised elsewhere?

Thomas' recent recording of Boccherini's famously virtuosic Cello chamber music with Sally Walker, made in the world class North Adelaide Baroque Hall and released on AVIE records, is currently Grammy-nominated.

Thomas has been reviewed with Alma Moodie Quartet across Australia, in effect playing an ambassadorial role for Adelaide
