The Council's *Cats By-law No 7 of 2025* (the **By-law**) limits the number of cats that may be kept on premises. Clause 7.1 of the By-law provides that a person must not, without the Council's permission, keep or cause, suffer or permit to be kept more than two (2) cats on any premises (this prohibition is subject to the exclusions prescribed by clause 7.2). This form is to be used by a person who wishes to apply for permission to keep more than two cats on the premises the person occupies
