



# BACKGROUND

The City of Norwood Payneham & St Peters is developing a Masterplan for Felixstow Reserve, which will guide the redevelopment of this significant piece of open space.

The Felixstow Reserve Masterplan is being undertaken concurrently with the Waterproofing Eastern Adelaide Stormwater Harvesting and Re-use Project, which proposes a new wetland at Felixstow Reserve.

A key objective of the Masterplan is to identify the best location and shape for this wetland. This will ensure that the proposed wetland is integrated into the overall design of the Reserve and that an innovative and well-designed outcome for Felixstow Reserve is achieved.

### **COMMUNITY CONSULTATION OVERVIEW**

Stage 1 of the community consultation, the 'Aspirations' Park Day was undertaken in March 2014.

Following this, the Felixstow Reserve Master Draft Concept was prepared and provided for community comment as part of Stage 2 consultation. The consultation findings will be considered in the refining of the Masterplan.

This report provides a summary of Stage 2 consultation carried out in May-June 2014.

### **STAGE 2 CONSULTATION PROCESS**

Stage 2 Consultation invited the community to comment on the Felixstow Reserve Masterplan Draft Concept.

The Stage 2 consultation process included:

- > Invitation/flyer letter-box dropped to nearby residents.
- > Information provided on the Council's website.
- > Signs promoting the Park Day located in Felixstow Reserve.
- > Advertisement in Messenger newspapers.
- > Consultation questionnaire.
- > Posters promoting the Park Day located at the three Council libraries and Norwood Town Hall.
- 'Park Day' held at Felixstow Reserve llam-2pm Saturday 31 May 2014. Residents and community members were invited to meet the project team and share their ideas and thoughts on the Draft Concept for the Reserve.

# **KEY FINDINGS**

### RESULTS

The Felixstow Reserve Park Day was attended by an estimated 120 people.

A total of 87 written comments were received. This comprised:

- > 69 Questionnaire forms.
- > 18 other written comments (e.g. email, letters, etc)

This feedback has been reviewed and is summarised below.

### Summary of key findings

- > Majority support for each of the features included Draft Concept
- > The aspects of least support are:
  - the bocce area (not considered needed)
  - the proposed wetland (primarily regarding loss of open space)
  - These are considered in the following pages.

A summary of the responses to each of the questionnaire topics is included in the following section. A copy of the questionnaire is included in the Appendix.

The table (above) and graphs (right) collate the responses to the questionnaire and also includes feedback provided in letters/emails received.


The feedback received indicates a majority support for all features listed.

The least supported features (25% or greater) are:

- > bocce area (63% YES, 37% NO) refer Q3 for discussion
- > wetland & interaction with water (75% YES, 25% NO)

The main concern regarding the wetland is the **loss of open space** (14 responses).


- Other listed concerns (less than 5 responses) include
- location considered too close to houses
- mosquitos
- safety regarding water depth



### Question 3 - In the Activity Space, do you agree with the inclusion of a: Bocce area Multipurpose court

The majority of the respondents agree with the inclusion of the Bocce area and the Multi-purpose court.



### If No, what other items you would like to see included in the Activity Space?

Suggestions varied (including in letters/emails received). Those with more than one response included:

- > Tennis (6)
- > Fenced dog park (5)
- > Table tennis (3)
- > Structured play items (2) including DDA accessible items

### QUESTION 4 - A natural play space is proposed for the Lower Park area. What types of natural play items would you like to see included in this area? For example, logs, ropes, stepping stones.

Responses to this open-ended question varied widely,

More common responses included:

- > Ropes / ropes course / rope swing (20)
- > Logs (18)
- > Stepping stones (16)
- > Climbing structures/ climbing trees (7)
- > Bridges, tunnels (5)
- > Flying fox (3)
- > Sand pit (2)
- > Jungle-gym, obstacle course (2)
- > Seating (2)

The main concerns regarding the lower park area include:

- > Keep natural, don't over develop, blend with the environment (4)
- > Flooding, too wet (4)
- > Grass gets too high, snakes, needs more regular mowing (2)
- > Poor visibility, over-grown (2)
- > Considered better location for wetland (2)

# *Question 5 - What fitness or activity station equipment would you like to see at Felixstow Reserve?*

Again, responses to this open-ended question varied widely,

More common responses included:

- Suggest similar to other known facilities Largs Bay (3), Willow Bend Reserve (3), Lochiel Park (2), Victoria Park, Windsor Garden
- > Ground surface suitable for push-ups, sit-ups (3)
- > Strength equipment (2)
- > Chin-up bar (2)
- > Lighting (2)
- > Undercover (2)

The main concerns for this topic:

- > Unsure if will be used/needed, suggest Lochiel Park equipment not used/poor condition (3)
- > Ensure doesn't take-away too much open grass area (2)

# *QUESTION 6 - Do you have any other comments or ideas that you think will assist in the development of the Felixstow Reserve Masterplan Draft Concept?*

Responses to this question tended to reiterate comments provided in questions 1-5.

Additional topics with multiple responses include:

- Concerns about the new car parking area on Riverside Drive (4).
  Main concerns included shifting crime, hoon driving, 'undesirable' activities from eastern car park
- > Support for safe bike paths/lanes (4)
- > Lighting (3)
- > More tree planting, native vegetation (3)
- > Cricket nets (2)
- > Drinking fountains (2)
- > Reinforced desire for DDA/Accessible spaces / paths (2)
- > Community garden (2)

Also a few comments and interest in the technical aspects of the wetland. Plus a few comments regarding the process of consultation in regard to consideration of the wetland.

### Felixstow Reserve Masterplan Draft Concept Released for Public Consultation

Monday 19 May 2014

The City of Norwood Payneham & St Peters has developed the Felixstow Reserve Masterplan Draft Concept, as the first stage in the master planning process for the redevelopment of Felixstow Reserve, in order to enhance and realise the full potential of this significant regional open space asset.

The Felixstow Reserve Masterplan Draft Concept, endorsed by the Council at a Special Meeting held on Monday 12 May 2014, will be released for public consultation from Wednesday 21 May until Friday 13 June 2014.

City of Norwood Payneham & St Peters Mayor, Robert Bria, said that the Felixstow Reserve Masterplan is being undertaken concurrently with the Eastern Region Alliance (ERA) Waterproofing Eastern Adelaide Stormwater Harvesting & Re-use Project, which proposes a wetland at Felixstow Reserve.

"The Draft Concept has been developed by the Council, in conjunction with the consultant, Oxigen Landscape Architects, taking into consideration feedback from the community, which was generated during the first stage of consultation, undertaken in March this year," said Mayor Bria.

"The Draft Concept incorporates the wetland component, which is part of the ERA Waterproofing Eastern Adelaide Stormwater Harvesting & Re-use Project, in addition to a range of improved community amenities including pedestrian and cycle pathways, BBQ and picnic facilities, new public toilets and car parking.

"Natural play equipment, fitness equipment, a bocce area and a multipurpose court are also proposed as part of the Draft Concept," he said.

Consultation on the Draft Concept will be held from Wednesday 21 May, with feedback to be received in writing by 5.00pm, Friday 13 June 2014. A copy of the Felixstow Reserve Masterplan Draft Concept can be viewed on the Council's website, www.npsp.sa.gov.au.

To help facilitate consultation on the Draft Concept, the Council is also hosting a Park Day at Felixstow Reserve, which is an opportunity for the community to provide their feedback in person.
